### The HOD in Action

Following a fine presentation by SBM **Lou Benedict** as keynote speaker, the HOD took a number of actions:

- 1. **Changes in the SOP** It approved number of for 2010. They are:
  - Five-riser/ 4-step configuration plus a configuration for larger choruses as needed, will be the chorus contest norm
  - Added a job description for a new Chairman of Financial Development, a DMT member.
  - Reduced to 50 miles (instead of 100) between shows on the same date without a waiver.
  - District Nominating Committee will continue to propose candidates for the International BMAL slots
- 2. **The annual FWD Memorial** carried the names of 51 brothers that have passed on since the last Fall meeting. One bright spot, however, was the error of inclusion of one member, **Scott Sievert**, who is reported very much alive --despite the report of his demise.

#### 3. New Chapter Formed.

## The Board Meeting in Brief

President **Bob Lally** opened the last board meeting of 2009,, also the last board meeting of his administration, at 2 pm at the Hyatt Hotel in Sacramento on Thursday, October 8, 2009.

- 1. The board welcomed new member, Ted Sayle, DVP Arizona Division, recently elected to replace retiring Gordon Bergthold.
- 2. All officers provided updates on their written reports as published in the Delegate's Fall Delegates Brochure.
- 3. The Invited Chairmen provided details augmenting their reports in the Fall Delegates Brochure.

The modified agenda included the following that were not included in the brochure:

- a. **Keith Eckhardt**, reporting on District membership status, noting that, among other points of interest, that the average age of member in FWD has *dropped* 6%! Further, that free registrations had been offered to the college or high school singers that would like to attend the convention. (results to follow)
- b. **Richard Lund** reporting on the continuing success of the Youth Camp under his aegis.
- 4. The board was provided a proposal by Marketing and PR Chairman, Dan Jordan, for a promotional "Enhanced CD"(not quite a DVD) and accompanying brochure to be used by chapters and the district alike. The "Enhanced CD" will contain: documents., links to International et al., pictures, map of the FWD Chapters, logos, DVD footage of champion performances, audio samples, anda Power Point presentation. The accompanying tri-fold full color brochure will provide a visual picture of the many facets of the district and will identify the contents of the Enhanced CD. He sought and received approval for a quantity of 5000 of each subject to approve of the final material
- 5. **Gordon Bergthold**, now Chair of the CSLT gang, presented his plan for a new Chapter Service Representative to replace the Chapter Counselors with specialists in different categories to help the chapters to succeed.

#### 6. Motions:

- To dedicate the Spring 2010 Convention to Sam Barger (MSP)
- To approve the funding of the FWD promotional enhanced CD and brochure as presented, at a cost not to exceed \$4200, subject to approval of the final product. (MSP
- To authorize the treasurer to allocate monies from the Harmony Foundation Fund to pay for the category School for judges candidates and others needing to attend school. (MSP)
