## President's Message



**Bill Rosica, FWD President**

### The State of the District

Hello to all the members and friends of the Far Western District (FWD). I hope everyone has stayed safe through this pandemic which has altered our hobby to its roots. For those who have gone through the Covid-19 illness, I pray for a full recovery and for those who have lost friends and loved ones, my thoughts and prayers are with you and yours.

Who could have known that last March would be the last time we met to harmonize together? As for me, March 11, 2020 my chapter was being coached in preparation for International. The next week we were home waiting to see how long this virus would last. Here we are now still wondering the same thing.

During this time, your Board has been working on many fronts with the Society and Chapters throughout the District. Your Division Vice-Presidents (DVP) have been tasked to meet with their respective Chapters through ZOOM®. I have asked that each DVP set up quarterly meetings with their respective chapters to assist those chapters in planning their direction during this Pandemic. If you have not been contacted or have not participated in these meetings, please contact your DVP for additional information.

There have been quite a few programs which were cancelled over the past year which made it difficult to operate. Many chapters had their spring shows cancelled as well as Divisional and preliminary contests. Of course, International in Los Angeles fell victim to Covid-19 as well. Our Fall Contest at Sea was not cancelled, merely postponed until October 2021. Now that Convention has been cancelled. Those chapters who planned for Christmas Shows had to re-design their efforts and worse yet, some cancelled altogether.

Not all the news is bad, however. Your District had some major shortfalls because of low attendance at our two major Conventions and Contests prior to 2020. Because of the District not having these contests, we made up some of our lost revenue and are on our way to being solvent once again. We also saved money on the Board traveling to these conventions to hold our Board

Meetings and House of Delegates (HOD) Meetings. I am sure there are a few saying, “If they didn’t have those meetings, maybe we really don’t need them”. Well, we did have those meeting using ZOOM®. And yes, we still need to conduct District Business a couple of time per year. Actually, we had quite a few more participants than we normally do at face-to-face HOD meetings.

Scott Suwabe, District Chorus Development Manager has begun putting the Director’s Guild back together. This will allow budding new musicians to get the coaching they need to become a Front-Line Director. They will also train Section Leaders and Assistant Directors. This is a very important piece of our puzzle to get our membership back to your chorus. Please give Scott a call with any questions. Charles Carothers, District Community Outreach Manager with assistance from Rob Menaker, VP of Music and Performance are in the planning stages of introducing our hobby to some of the underserved communities. This project has been pushed out to February of 2022 but should be a real fruitful endeavor. Both Jeremy Loper, District Membership Manager and Kenny Rios, District Youth in Harmony Manager had plans for 2020 and 2021, but Covid-19 kept them from implementing anything concrete.

Since we were able to save money and decided not to change the dues schedule, look for some discounts on upcoming conventions and your Leadership Academy was held via ZOOM® at no charge. This year we elected two new Division Vice-Presidents, Rich Postal Northwest Division and Kathy Kileen, Southwest Division. We welcome both to the Board with Kathy being the first female on the Board.

At this time, the International Quartet Contest in Cleveland is still a “Go” and will be ready for competitors in July. The Preliminaries for quartets will be held with video submittals. Brett Littlefield is working to get that nailed down, so keep an eye out for more information.

Our Fall Convention and Contest at Sea, on the calendar for October 15-18, 2021 has been re-worked and will not be held at sea and Donna Hisey is working on a Non-FWD Sponsored barbershop theme cruise in its place. The Cruise line moved our Deposit deadline from February to March 13th which gives her an additional month to make plans. Carnival also gave each cabin that rolled over their reservation from 2020 a \$300.00 on-board credit and an upgrade to your cabin. Since the District Board decided that a contest is not feasible, we have had some discussions regarding a “ Coming out of Covid Cruise” with those of us still interested in having a little fun. Please know that your safety is of ultimate concern to the Board. We are in contact with Carnival through Donna Hisey to make sure all the CDC Protocols will be followed. Hopefully, the vaccine will be a good start on being able to conduct this cruise safely.

In talking to the other District Presidents, I find that the FWD is in great shape. We have some plans for late this year as well as early 2022 which involves the AIC and some of our local chapters, so stay tuned. As a final thought, I want to barrow something Erin Howden said at The Masters Installation in January. She said, “You are exactly where you should be”, which is another way of saying There is a reason for everything. Make the best of what you’ve got. Look forward not backward. What can we do to make ourselves better when this Pandemic is over?

I can't wait until we can all be together again at a Contest/Convention. Until then, stay safe and keep up the virtual singing!




**Jim Maass, Secretary**

Additionally, check to be sure your incorporation with the State is up to date and current with any additional officer changes.

Take Care and hopefully we will all be singing together in person and ZOOM will be left to Mighty Mouse as he flies to his next adventure.



**Rich Owen, Treasurer**

Last year, The HOD allowed funds that would normally be allocated to international contest travel to be reallocated back to our general funds. In view of the impact of COVID on District and BHS operations, I have not made any allocations of funds to international contest travel during 2020, and it appears likely that there will not be any international contest travel in 2021. I therefore request authorization to not resume such allocation until international contest travel resumes in 2022.

All tax returns for 2019 for the District were filed before the deadline of November 15, 2020.

Attached are the *preliminary* P & L Statement and Comparative Balance Sheet for 2020 which are located at the end of the HOD brochure. I have some adjustments to make for old outstanding checks and other year-end adjustments. Because the District had basically minimal expenses during 2020 due to the COVID shutdown of all conventions and contests, we had a financially successful year. Gross revenue was \$65,587; expenses and refunds were \$8,817; net income was \$56,769.90.

I'm happy to report that both my sense of smell and taste have returned, and Isaura and I are doing very well. We are grateful to the Lord as we are aware that many friends have had serious bouts with this virus. Isaura was born with a weakened immune system, and I have eight stents in my heart from heart disease, plus prostate cancer.

So, let me suggest that you take time to connect with your chapter on the weekly Zoom calls. It is an excellent way to stay in touch with the folks you've enjoyed singing with prior to this pandemic. It is nice to see those familiar faces and share some good-natured ribbing while singing a few songs. And, you're right! It's not the same, but until we can come back together, it's an alternative I can live with.

Another option: Meet together with some of your barbershop friends and, using social distancing and masking, join together singing the Old Songs. I get together every few weeks with anywhere from 8-12 guys to sing and it reminds me of how much I enjoy this hobby, and why I love ringing those chords.

Please feel free to contact me and let me know what type of guest you are looking for and I'll match you with someone who can help you out. We have another very exciting program that I mentioned previously but wanted to mention it again. At this time, the SCVA Close Harmony Festival is still on track for the Spring of 2022. The tentative plan to promote this festival is as follows:

\* April 2021 will open slots to high school music educators for appointments from AIC quartets in Sep/Oct 2021. This will give music educators plenty of time to schedule plans for these visits by quartets.

\* Sep/Oct... 5-6 AIC quartets will descend on LA-area high schools for in-person singing, training, etc. Thursday, Friday.... hoping to visit underserved communities where 50% of students are on free or reduced meals. The purpose of these visits is to promote the Feb 2022 SCVA Festival.

\* Sep/Oct... On Saturday, LA area chapters will produce a show featuring AIC quartets, and local choruses singing 2 songs each (presumably their contest set)

\* Feb 2022... SCVA Festival and show with AIC quartets and possibly the entire AIC and all its members to reprise the LA, 2020 show with charts and plans already designed.

Obviously, there are LOTS of details to work out (and we are at the mercy of the status of the pandemic), but if you are in the Southern California area, please be on the lookout for this to roll out this spring.

This will be a major outreach event at no cost to the District, so it's a win-win!

## **Management Team Reports**



**David Melville, Marketing and Public Relations**

Over the past several months Don Shively and I have been working extensively in the Event Farm Virtual Campus used for the BHS Midwinter Convention. It was a wonderful experience, and FWD can be proud of the showcase that Don and I put together.

I also attended Part 1 of a seminar on “Pandemic Compliance & Safety at Live Events” in February which focused on mainly the health and safety issues, and will be attending Part 2 in March that will cover the legal and liability aspects.

As a result of uncertainty regarding the pandemic status by October, the need to make a Go/No-Go decision in March, and the question of when competitors can start meeting safely to rehearse, the FWD Board made the cautious decision to forego the Convention and Contest events that had been planned for the Fall Cruise, and we are presently looking at some alternative solutions. One proposal, a.k.a. “Plan B”, is under investigation, and that is to hold an in-person convention in Fresno. However, as wonderful as that sounds, that too is uncertain until we better understand the pandemic situation and the impact of vaccinations; the CDC and/or the State may still have regulations in force by October that would prevent such an event from happening.

That being said, I feel it is essential that we have SOME type of event this year, if for no other reason than to give our members something to look forward to, so I have been developing a “Plan C” unitizing the Event Farm for a “hybrid” fall event. The Event Farm has many advantages over a Zoom webinar in that it has an excellent way to offer social interaction, live performances in a safe environment, and yes, even has the potential to serve as a “venue” for contests wherein the competitors actually get to see the audience response.

Judy Galloway (EVG) and I have been meeting with Dusty Schleier (BHS) as well as with Tom Shima (Event Farm) to talk about possibilities and pricing for either A) “renting” the BHS event farm for one or more events, or B) contracting directly with Event Farm for our own virtual campus. Both BHS and Event Farm are very keen on the idea and willing to be flexible. I don’t want to publish any figures in this report because we are still going back and forth, but hopefully I will have something solid to report by the Spring meetings.

On another front, BHS has, as most of you know, dumped their home-grown member system and replaced it with a new and “improved” Member Center II. To say it has been a less-than-successful transition would be a gross understatement. I am preparing a detailed analysis of all of the flaws I have uncovered, but I think it is going to take a lot more than individuals hollering to get anything done, and so I encourage President Rosica to engage with other district presidents to form a united coalition to lobby BHS to make necessary changes.

*Editor's Note: The following message was sent directly to all FWD members who had signed up for the Fall Convention at Sea. This letter is being included in this HOD brochure for historical purposes.*

Far Western District Family and Friends:

As you all know by now, your District Board decided to forego the "Contest at Sea" for October 2021 because of a couple of key points:

- The State of California, the Federal Government, the Center for Disease Control and the World Health Organization cannot assure us that this Carnival cruise will be able to sail during the weekend of October 15-18, 2021.
- The Last day to have your deposit refunded is fast approaching (March 13)
- Those of you who did sign up and paid your deposit, were for the most part, audience members with very few competitors. This would have made for a very short contest.

Please note that we did not cancel the cruise. The Far Western District had to decide what was best for the District. We were excited to bring this type of activity to our District, but Covid-19 was just too unreliable for planning purposes. As of today, Carnival is still planning on sailing October 15 and returning on October 18, 2021. Some folks may want to join Donna and her husband Greg for a great time of sailing, singing tags and meeting up with old friends. Your upgrades and \$300.00 on-board credits are still in effect.

For those of you who choose not to go on the Cruise, your Board is working on Plan B, which is to hold our Fall Convention and Contest in Fresno on October 14-17, 2021. Again, the people who enable us to meet in person need to tell us when we would be allowed to gather and under what protocols. We are working as if that will be decided in our favor in the near future. However, we realize that each competitor will need some lead time to prepare for such an event, so Plan B, like the cruise is in flux.

These are uncertain times, and your Board realizes that the Contest at Sea came at the worst time, due to Covid-19. If you have any questions or comments, please feel free to contact me. I don't have all the answers, but I know the Division VP's along with the rest of your Board will assist you in your quest.

\* SCVA Festival is postponed until Feb, 2022...

\* Committee will reconvene in Jan, 2021. Tim to send out invitation for meeting after first of the year.

\* Promo video will be prepared for viewing during the time the 2021 Festival was scheduled to occur. The video will promote the option of having AIC quartets come to their high school in Sep/Oct 2021. Tim will get with production team to help Antone assemble the video. Will include in 2021 HFI budget for fundraising to help cover costs of the video production.

\* April, 2021 will open slots to high school music educators for appointments from AIC quartets in Sep/Oct 2021. This will give music educators plenty of time to schedule plans for these visits by quartets.

\* Sep/Oct... 5-6 AIC quartets (depending on the need - will budget for 5-6) will descend on LA area high schools for in person singing, training, etc. Thursday, Friday.... hoping to visit underserved communities where 50% of students are on free or reduced meals. The purpose of these visits is to promote the Feb, 2022 SCVA Festival.

\* Sep/Oct... On Saturday, LA area chapters will produce a show featuring AIC quartets, and local choruses singing 2 songs each (presumably their contest set)

\* Feb, 2022.... SCVA Festival and show. with AIC quartets and possibly the entire AIC and all its members to reprise the LA, 2020 show with charts and plans already designed.

Funding:

HFI will seek funds from donors to underwrite all aspects of the plan..... In this case this program touches on three (3) of AIC/HFI initiatives.... a) SCVA Close Harmony Festival.... b) Underserved Communities.... c) providing AIC quartets for shows with struggling chapters

## **District Management Team Reports: Nick Papageorge**

Executive VP Nick Papageorge introduced each of his team members to give their status updates.

**Membership, Jeremy Loper.** Jeremy shared membership numbers. All the districts are down in membership. FWD is down as expected with COVID. Current membership is 1548 down from 1996 a year ago. He is encouraging chapters to “mix things up” on ZOOM and give the guys an interest in showing up.

**Chorus Director Development. Scott Suwabe.** Not much to report. He is getting all director/assistant director contact info and will be setting up a ZOOM meeting. Also looking to get all of them back involved with a reestablished Directors Guild.

**Convention Manual. Bryan Forbes.** Bryan had left the meeting early. No report.

**Convention Venue Rotation. Bryan Forbes.** No Report.

**Convention at Sea. Carnival Cruise Update. Bill Rosica/Donna Hisey.** Bill mentioned that we are planning for the positive. Donna gave an update status. CDC requirements for cruise lines to submit sanitation plans before resuming operations. Cruise lines are working on regulations with health experts and the CDC. A 64-page plan has been submitted and they are waiting for approval of the new health protocols. She

reported that the new ship the FWD will be on is being upgraded with CDC protocols for COVID safety (\$200M) and will be on the West Coast by April 2021. Also, there will be a \$300 on board credit for each cabin as well as cabin upgrades at no additional cost for those who have had their reservations transferred over to the new ship. (Ex., an inside cabin upgraded to an outside cabin, an outside cabin upgraded to an outside balcony cabin, etc.) There are 345 cabins booked. There are approximately 15 canceled cabins and Donna is holding them to resell to District Members at the 2019 price. She will have to release them to Carnival by the end of November. The ship will sail at ½ capacity so she expects the ship to sell out by January 1<sup>st</sup>. The dates have changed (Oct. 15 to Oct. 18) -- a Friday afternoon departure returning 7 AM the following Monday morning instead of the previous Thursday to Sunday schedule. This would allow locals to not miss work on Monday.

**Marketing and Public Relations. David Melville.** David asked if additional cruise advertisements should be prepared. He will let the board decide on that question. There was no direction given. He is working on new web calendar software. Also, a new version of the reservation software will be available in November. Regarding the convention venue schedule, David expressed hope that the schedule would be pushed out a year so Mesa AZ would not have to wait five years for the next contest in the cycle. Bryan Forbes was not in attendance to confirm the schedule. Bill Rosica indicated that the contest should be pushed out a year and will contact Bryan to check it out.

**Youth in Harmony. Kenny Rios.** Since there is no activity at the high schools with music programs, there is nothing to report. There will be no HS quartet contest until the divisional contests resume.

**Financial Development, Endowment Funds. Roe Darnell.** Roe was not in attendance. No Report.

**Directors Guild. Scott Suwabe/Nick Papageorge.** Nick has found the folder with the information on the early beginning of the Guild. Scott will be meeting with the directors to see where it goes from there. Looking to set up an initial meeting before Thanksgiving. President Bill asked that it occur before November 14<sup>th</sup>.

## Old Business

**Financial Review. Rich Owen.** He reported that there have been very little expenses (\$8286) this past year due to inactivity of events and in person board meetings. The district is in the black -- \$45,352. He has also been busy with grant applications for his chapter and will be doing the tax filing information later this year. There was some discussion on how to address the extra funds the district has. No action was taken.

**Leadership Academy/Harmony College West. Jeremy Loper/Scott Suwabe.** Everything is on hold. There was discussion about doing the Leadership Academy “online” and making it free to participants. President Bill suggested that a plan be

developed by November 15<sup>th</sup>. He would join Jeremy and Scott in developing that plan. If there are any expenses, there are funds available.

It would provide virtual meeting for lectures, group gatherings, virtual conventions etc. and the license would be for the full year. Cost \$27,000 to be shared with EVG. There was some discussion.

It was then suggested that maybe this discussion was the “cart before the horse” since the board had not yet discussed or taken any action on the agenda topic for the evening—The October FWD Convention at Sea. At this time discussion switched to the FWD October Convention and Contest to be held aboard the Carnival Cruise ship.

Donna Hisey, Expedia Cruise Consultant gave an update on the status of the ship that will be used and that it was ready and awaiting CDC approvals. There will be test cruises starting shortly to check out all the Covid related upgrades before the sailing public will be allowed on board.

She also reported that the deadline for passenger cancellation for a deposit refund has been extended by Carnival to March 13, 2021. This will be the last deadline extension.

There were quite a few questions and answers and discussion. This biggest issue: Should there be a contest on board? The discussion centered around those barbershoppers who have registered and that it appears that there is more spectator registered for the cruise and very few contestants—either chorus members or quartet members. President Bill expressed concern that if there is “no contest” many will cancel their booking. After some discussion, the following motion was made.

**It was moved and seconded to cancel the contest portion of the convention at sea.** Motion Passed, All Aye. There will be no FWD contest on the cruise. However, there was some further discussion that there might be alternate contest/convention plans made. Details to be determined.

After a very lengthy discussion regarding “should the FWD convention on the ship be held at all?”-- the following motion was made by Rich Owen and seconded by Craig Hughes.

**The Far Western District will withdraw sponsorship of any contest or barbershop related events to be held on the October 2021 Carnival Cruise.** Motion passed. 10 voting yes, and two absent.

General discussion continued regarding how to get the word to the members that there will be no FWD sponsored Contest and Convention aboard the Carnival Cruise ship in October. Donna also indicated a desire to organize a “barbershop event” aboard the ship independent from any official FWD participation. A survey will be developed and sent out within the next several days to see what interested there might be.

There being no further business, the meeting was adjourned at 7:40 pm.

Here's the plan developed by the group during the zoom call Sat Sep 19 .

\* SCVA Festival is postponed until Feb, 2022...

\* Committee will reconvene in Jan, 2021. Tim to send out invitation for meeting after first of the year.

\* Promo video will be prepared for viewing during the time the 2021 Festival was scheduled to occur. The video will promote the option of having AIC quartets come to their high school in Sep/Oct 2021. Tim will get with production team to help Antone assemble the video. Will include in 2021 HFI budget for fundraising to help cover costs of the video production.

\* April, 2021 will open slots to high school music educators for appointments from AIC quartets in Sep/Oct 2021. This will give music educators plenty of time to schedule plans for these visits by quartets.

\* Sep/Oct... 5-6 AIC quartets (depending on the need - will budget for 5-6) will descend on LA area high schools for in person singing, training, etc. Thursday, Friday.... hoping to visit underserved communities where 50% of students are on free or reduced meals. The purpose of these visits is to promote the Feb, 2022 SCVA Festival.

\* Sep/Oct... On Saturday, LA area chapters will produce a show featuring AIC quartets, and local choruses singing 2 songs each (presumably their contest set)

\* Feb, 2022.... SCVA Festival and show. with AIC quartets and possibly the entire AIC and all its members to reprise the LA, 2020 show with charts and plans already designed.

Funding:

HFI will seek funds from donors to underwrite all aspects of the plan..... In this case this program touches on three (3) of AIC/HFI initiatives.... a) SCVA Close Harmony Festival.... b) Underserved Communities.... c) providing AIC quartets for shows with struggling chapters

President Bill mentioned that Midwinter will be in Pasadena in 2022.

**District Management Team:** Nick Papageorge introduced his team members for their reports.

**Membership. Jeremy Loper.** No report.

**Events. Bryan Forbes.** Absent. No report

**Convention Manual.** No Update

**Cruise Update.** Donna Hisey gave an update status. CDC requirements for cruise lines to submit sanitation plans before resuming operations. Cruise lines are working on regulations with health experts and the CDC. A 64-page plan has been submitted and they are waiting for approval of the new health protocols. She reported that the new ship the FWD will be on is being upgraded with CDC protocols for COVID safety (\$200M) and will be on the West Coast by April 2021. Also, there will be a \$300 on-board credit for each cabin as well as cabin upgrades at no additional cost for those who have had their reservations transferred over to the new ship. (Ex., an inside cabin upgraded to an outside cabin, an outside cabin upgraded to an outside balcony cabin, etc.) There are 345 cabins booked and there have been no additional cancellations. The ship will sail at ½ capacity, so she expects the ship to sell out by January 1<sup>st</sup>. The dates have changed (Oct. 15 to Oct. 18) -- a Friday afternoon departure returning 7 AM the following Monday

morning instead of the previous Thursday to Sunday schedule. This would allow locals to not miss work on Monday.

**Marketing and Public Relations. David Melville.** He gave a brief report on what the cruise PR will be in the coming months. There was some discussion.

**Youth in Harmony. Kenny Rios.** He reported that the schools are not doing much in the way of music so everything is on hold. Not moving forward on any HS quartet contest planning at this time. He mentioned that a new chapter was forming in Las Vegas...mainly younger guys.

**Chorus Directors Guild. Scott Suwabe.** He discussed that he is getting the "Directors' Guild back up and running and will be contacting chapter directors, assistant directors in the coming weeks with information. He is looking to have quarterly director ZOOM meetings.

**Financial Development. Roe Darnell.** Absent. No report.

**Finance Update. Rich Owen.** He presented the financial statements through September. The district is in good shape. The documents will be posted to the FWD website. Bottom Line: Income \$53,648. Expenses \$8,286. Net Balance. \$45,352.
